Show Requirements:

February 15th, JURIED ENTRIES CLOSE – NO EXCEPTIONS

1. All work must comply with the definition of **ORIGINAL WORK!** “Original work”, the artists own creation which has NOT been copied or duplicated from another person’s drawing, photograph or design.
2. Artwork presented that has NOT been previously exhibited at another Havasu Art Guild Judged Show.
3. All artwork must be of a quality considered Fine Art.
4. Only **RECENT** work done within the last two years is to be exhibited.
5. All artwork must be **OF FINISHED QUALITY** – dry, framed, and ready for hanging with screws and wire with sufficient slack for hanging, All work must have an **“ENTRY SLIP”** secured to the lower right side or underside of each piece.
6. The guild, by vote of show committee chairs, **CAN** refuse work determined to be lewd, pornographic, violent, or inappropriate. Please send a photo of your work with your entry if you are unsure.
7. The Havasu Art Group will retain 20% commission of the purchase price of any item sold off the floor or in the Gift Shop. Artist’s Card with ID#, Name, Title, Category and Price will be attached to the judged entry. If **NOT FOR SALE, NFS** will be stated on the card, but you must indicate this on your application.
8. Business cards may **ONLY** be displayed at the cash register table.
9. An **ARTIST BIO** on an 8.5 x 11 sheet of paper and at least three photos of your work should be available for our Artists’ Bio Book before, during and after the show.
10. **JUDGED ART SALES:** Items sold must be presented to the buyer by the selling artist March 11 – 2:00 PM **SHARP.**
11. **Artists work will be removed at 2:30 PM. Room break down will be 3:00 to 4:00 PM.**

Categories and Descriptions:

Each entrant may have 6 entries in any combination of Categories. All entries will be juried before they are judged.

<u>Category</u>	<u>Description</u>
1. Oil Painting	<i>Oils, Paint Sticks & Oil Pastels</i>
2. Water Media	<i>Watercolor, Gouache, Tempera, Watercolor pencil</i>
3. Acrylic Painting	<i>Acrylics</i>
4. Pastels	<i>Pastel Chalks</i>
5. Graphic Arts	<i>Pencil, Charcoal, Colored Pencil, Crayon, Pen & Ink, Etching, Scratchboard, Monoprints, Block Prints</i>
6. Mixed Media & Collage	<i>Two dimensional using 2 or more medium on a surface (one sided)</i>
7. A'ssembla'ge	<i>Three dimensional (3 sided) with multiple parts, pieces of any media joined.</i>
8. Ceramics	<i>Clay – Hand Thrown, Hand built – functional or decorative</i>
9. Sculpture	<i>Three dimensional (3 sided) in stone, clay, wood, plastic, gourds, etc.</i>
10. Glasswork	<i>Original fused, stained, etched, lampwork non-jewelry items.</i>
11. Jewelry (Hand Crafted)	<i>Jewelry of your own design using 75% or more of your own handmade or crafted elements; handmade glass beads, hand/machine carved gems and stones, hand crafted silver/gold settings-including copper, bronze and brass chains excluded.</i>
12. Jewelry (Creative Design) own	<i>Jewelry of your own design using a minimum of 25% of your handmade jewelry elements, silver/gold fittings or settings, also pre-cut stones and gems.</i>
13. Photography	<i>Original Black & White, Color</i>
14. Digital Fine Art	<i>Original rendering, collage, or painting using a computer program as a medium.</i>
15. Fiber Art	<i>Batik, Cloth, Basketry, Weaving, Handmade Paper, Silk, Painting, Cloth Textile</i>

There will be a \$15 Charge for members showing work in the juried show then **AFTER FEB 15th** a member may enter with a \$40 fee. The Group will retain 20% of all sales.

RULES:

1. All items must be properly tagged. Use **Large, single tags** with your ID Number and initials on one line. On the second line, show the amount.
Must be legible!!!!
2. **Do Not** use stickers, tiny tags or two part tags
3. **Do Not** use fractions of a dollar
4. Each artist will be allowed one (1) space. (A space is ½ round table (6ft in diameter), one (1) 6 ft rectangular table with two (2) screens, or only three (3) screens. Extra space will be provided for an additional fee of \$5 for each table or screen, and only if space is available.
5. Gift Shop Show Chair determines final space allocations for all artists.
6. **All artwork should be suitable for a Fine Art Show.**
7. All artwork must be handcrafted by the participant and of quality craftsmanship.
8. Prints of your own work are acceptable, if identified as prints.
9. ALL PARTICIPANTS are required to work at least two 3 hour shifts during the show's run.
10. Please proper attire and wear your name badge while working.
11. **Gift shop items are not to be removed before 2 pm Sunday. All Items must be removed by 3pm.**
